

Format:

Session 1:

Young Professionals...Young Leaders

As the young professionals of today you will play a vital role in shaping and leading the oil and gas industry of tomorrow. Like never before the leaders of the future will need to combine superior technical skills with the ability to act decisively inspire others and deal with the challenges of an industry that is changing at an everincreasing rate. Our ability to innovate and harness the shared creativity of our teams will be the key to developing the new technologies that will determine the long-run winners and losers in our business.

This interactive session will bring together leaders from today's industry to share their experiences and learnings. You will gain insights into how they made a difference in their careers and how you can maximise your own impact in the diverse environments in which you work today and in the future. Through sharing and debate we hope you will leave the session with a better understanding of the skills and behaviours that will be the building blocks of your future as a successful industry leader.

Session 2:

Innovative Technology sustains Tomorrow's Energy

1400 - 1715 hours

Technological innovation has been and will remain the turning key of the petroleum industry toward the supply of the fuels that power the world economy. Advancement in technology has facilitated means for the industry to economically develop large oil and gas deposits and recover hydrocarbons in a cost effective and environmentally safe manner It has enabled production from challenging reservoirs, where hydrocarbons are complex to retrieve as well as reservoirs located offshore and in remote and environmentally sensitive locations such as the Arctic or hot deserts in the Middle East.

Innovative technology in drilling (such as directional drilling, managed pressure drilling) and production such as enhanced oil recovery (EOR), has allowed the sustaining of wells for enhanced production. Real time data transmission allows engineers and geologists to collaboratively monitor drilling activity and reservoir conditions through decision centers (visualization centers) minimizing the need to be on the field. These fields are known as digital fields or i-fields.

As young professionals, keeping up with the state-of-the-art and effective technology will better equipt them to pave the way to successful careers and more productive oil and gas industry.

Session 3:

Your Career Your Choice

0830 - 1300 hours

The petroleum industry offers exciting career opportunities which cause a wide-range of career choices. There is no magic formula for career success, so it is important for young professionals to have enough notations to their career. Within the next ten years, many current senior professionals in the industry will have retired. All eyes will then be on the Young Professionals to lead the industry into the future. Now would be the right time to prepare and be ready.

This session will focus on various topics related to careers and the different available choices within and for the industry. Attendees will be able to realize the challenges of working with NOC or IOC versus service companies and how they all formulate a team for one objective. As a recent graduate you will learn how to bridge the gap between university and successful career in the industry where leaving the university does not mean you abandon higher education while working. On the other hand, you learn the importance of networking and how to utilize it to enhance your skills for your current job and take further steps for your career as well. You want to continue your development in your area of expertise and develop a strong internal network within your company, prove to your colleagues that you are capable, and prove to your managers that you are worthy promotions and consideration for higher positions.
